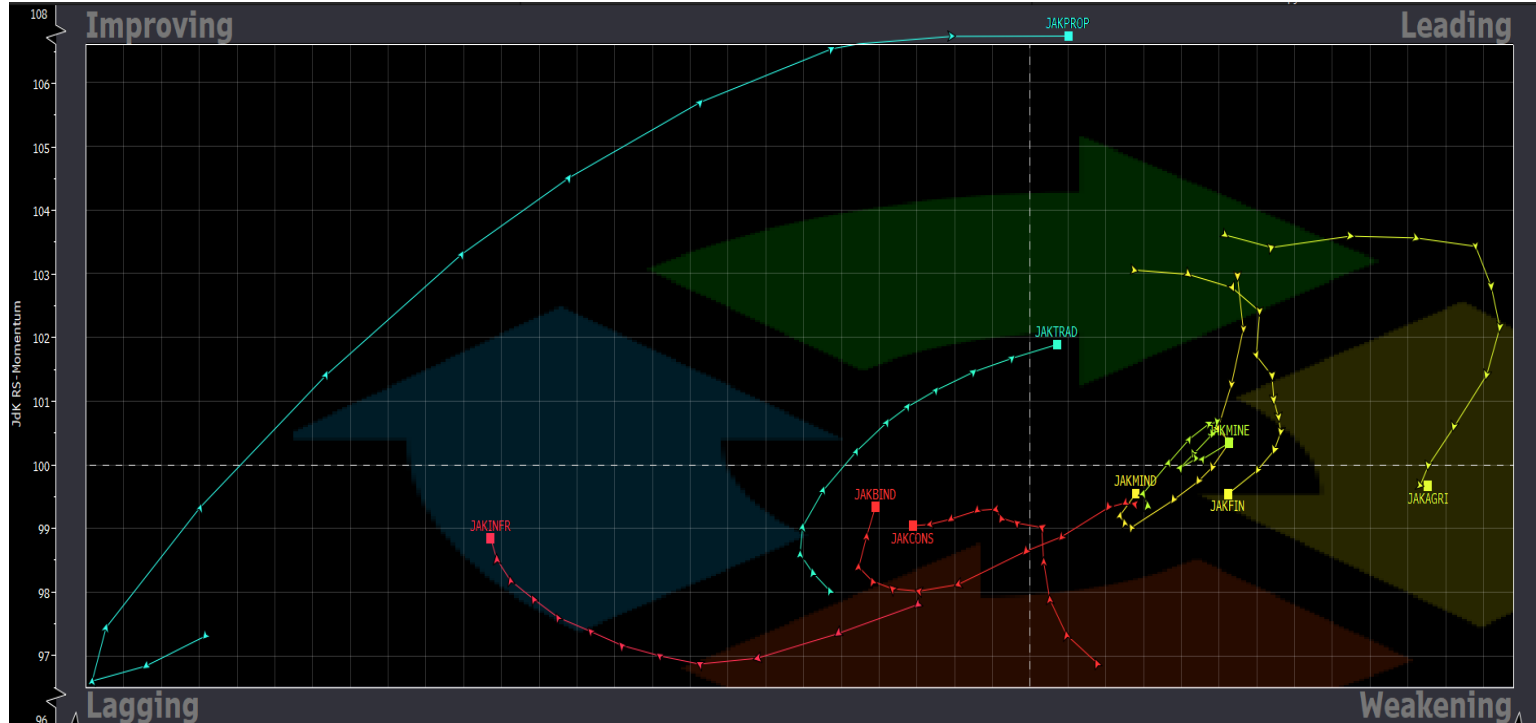
Jakarta Composite Index (JCI) *short term (1-2 days) bullish*

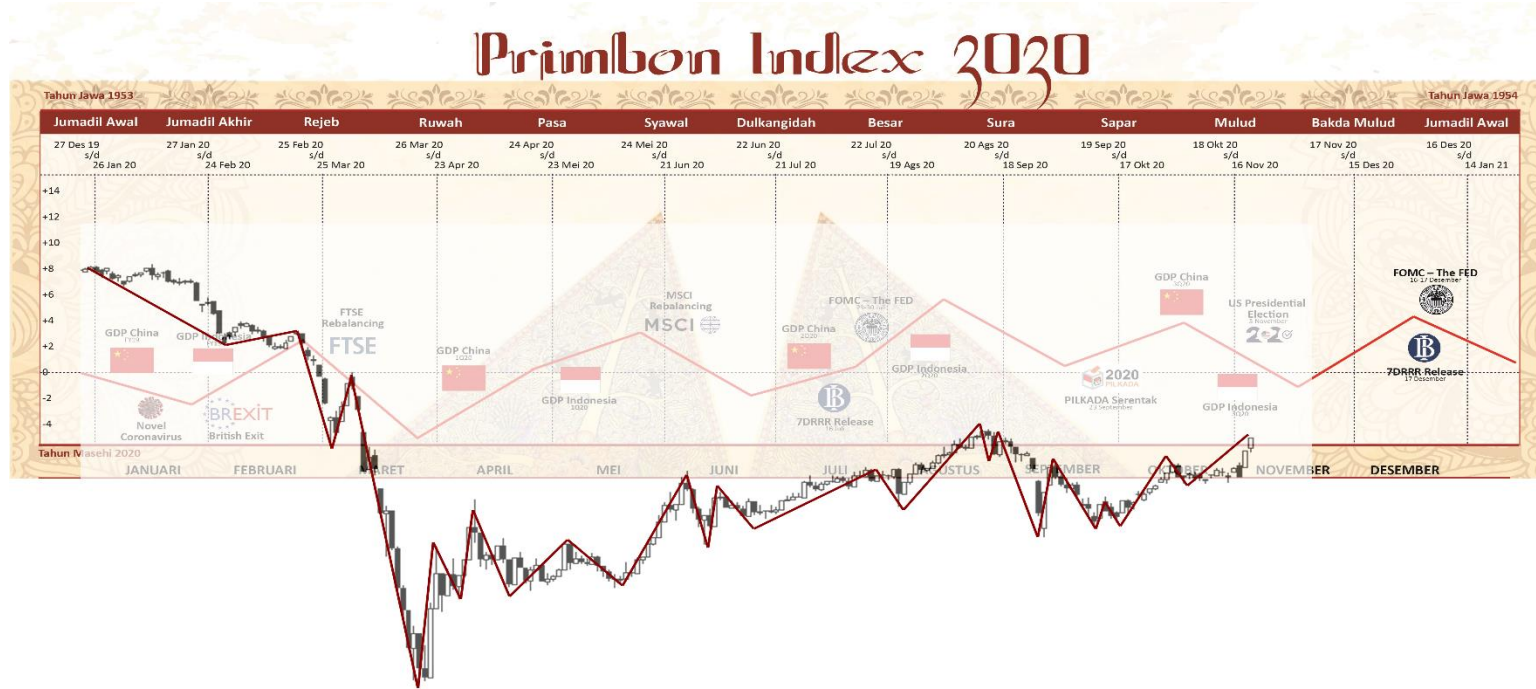

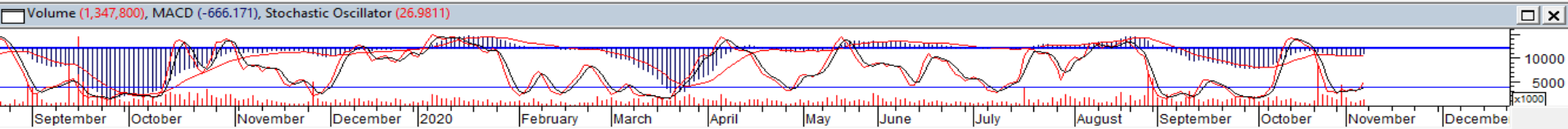
JCI – Beware

Dalam jangka pendek, IHSG rentan terkoreksi ke area 5,120-5,230 terlebih dahulu. Namun, apabila IHSG menembus 5,382, maka IHSG mengalami ekstensi untuk membentuk skenario merah wave [i] dari wave 3 dari wave (C) atau wave (3).

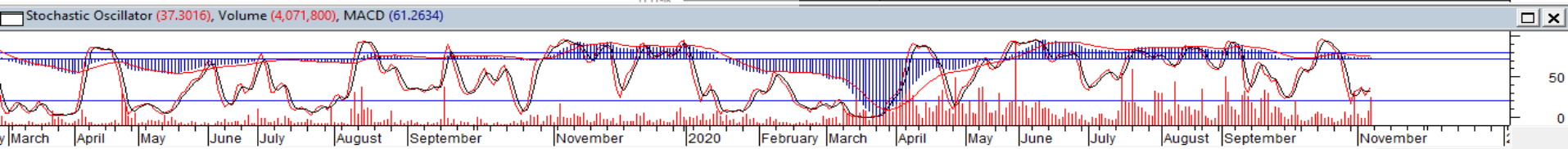


AAI – Buy on Weakness

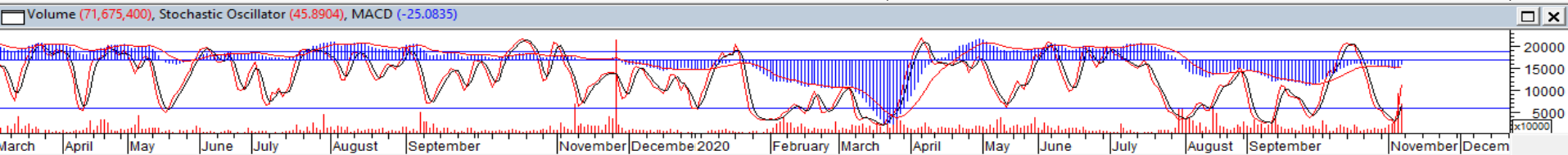

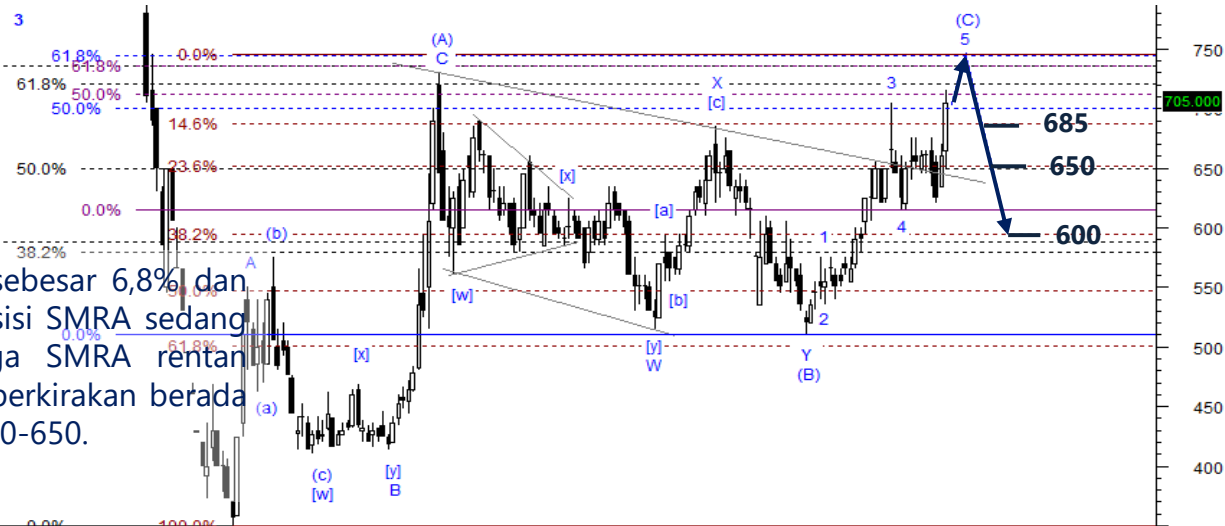

EXCL – Buy on Weakness

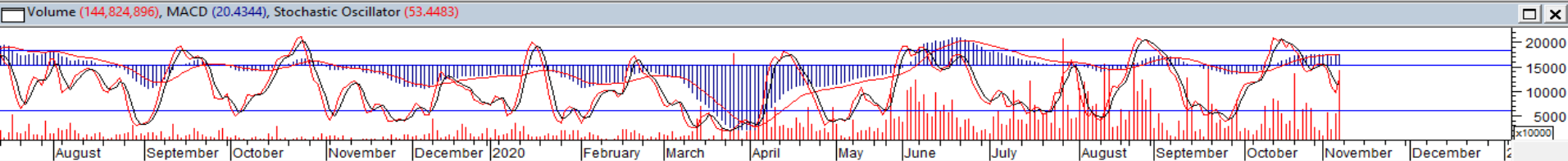


SMRA – Sell on Strength
